Location

Letchworth Garden City is the World's first Garden City, founded in 1903. It has a population of 33,249 (2011 Census) and is located in North Hertfordshire, approximately 32 miles north of London. The town has direct access to the A1(M), which offers links to the M25, 20 minutes to the south. Letchworth Garden City mainline railway station provides a fast service to London Kings Cross (36 minutes) and Cambridge (25 minutes) and is well located for the international airports at both Luton and Stansted.

The Spirella Building is a modern office building located in the centre of Letchworth Garden City, conveniently located in the town centre and a short walk to the railway station.

Description

The Ballroom is located on the third floor of The Spirella Building. There is a manned reception during usual office hours and the property benefits from lift access and shared toilet facilities.

The main ballroom has a bar area, mezzanine storage and a stage area with ancillary space.

The space may be suitable for leisure occupiers such as dance studios, theatre workshops or religious group meetings, subject to Landlord approval.

There are circa 70 parking spaces.
