Location

Letchworth Garden City is located in North Herts close to the Bedfordshire border and adjacent to Junction 9 of the A1(M). To the south, the M25 provides access to the national motorway network and to the north, the A14 connects to the M1/M6 and east coast ports. Letchworth Railway Station provides regular services, some non-stop to London Kings Cross, approximately 35 minutes. Such Close is situated in the town's principal commercial and industrial area off Works Road located close to the town centre and public transport.

The development comprises of terraced industrial units located on an established industrial estate. The subject property is an end of terrace unit providing principally clear accommodation with loading door and forecourt parking.
